Otsuka Holdings Co., Ltd. (Head office: Chiyoda-ku, Tokyo, Japan; President and Representative Director, CEO: Tatsuo Higuchi) has been recognized for leadership in corporate transparency and performance on climate change by global environmental non-profit CDP, securing a place on its annual 'A List' for a second consecutive year. Otsuka also received an A- listing for water security, placing it at leadership level in the category.

A LIST CLIMATE

Under its 2050 Environmental Vision, "Net Zero," the Otsuka group is committed to reducing the total environmental impact of its business activities to zero. Based on this vision, we have determined *carbon* neutrality, and water neutrality as the part of the material issues in our environmental initiatives. In terms of carbon neutrality, group-wide collaboration is focused on meeting the group medium-term target of reducing CO₂ emissions by 50% by 2028 compared to 2017, utilizing renewable energy by introducing solar power generation facilities and CO₂ free electricity, improving energy use efficiency by introducing cogeneration systems,*2 and pursuing fuel conversion and other measures globally. In terms of water *neutrality*, we have conducted water risk assessment at the group's all production sites worldwide in the aim of sustainable water use.
