<b>CHARACTERISTICS</b> Gastrointestinal medicine containing crude drugs					
Eight types of crude drugs are effective. (Turmeric, Glycyrrhiza, Ginseng, Coptis Rhizome, Clove, Gentian, Atractylodes Lancea Rhizome, Cinnamon Bark) + Carnitine Hydrochloride The medicine is effective for felling queasy (hangover, drunken sickness, sickness, churning of stomach, queasy, nausea), vomiting, dyspepsia, overeating (hyperphagia), overdrinking (binge drinking), and loss of appetite. It contains turmeric and glycyrrhiza, and has a cool menthol taste.

### Consultation

1. The following persons should consult a physician, pharmacist or registered salesperson before using the medicine.
  - (1) Persons under treatment by a physician
  - (2) Elderly
  - (3) Persons with oedema
  - (4) Persons diagnosed with hypertension, kidney disease or cardiac disease
2. The following serious symptoms may rarely occur after using the medicine. The following symptoms may be adverse reactions to the medicine. If any of these symptoms occur, discontinue the use of the medicine immediately, and consult a physician with this medicine.

Pseudoaldosteronism, myopathy (Weakness, numbness, tightness, and stiffness of limbs occur along with feelings of weakness and muscle pain, and they gradually get worse.)
3. If symptoms do not improve after using the medicine for five to six days, discontinue the use of the medicine, and consult a physician, pharmacist or registered salesperson with this medicine.
